**Zeina Barakat** is a Jerusalem-born Palestinian. She obtained a Bachelor's degree from Bethlehem University (2005) and went on to do a Master's degree in Regional Studies at Al-Quds University (2006). In 2016 she was awarded her doctorate degree from the Friedrich Schiller University of Jena, Germany, where she is currently a postdoctoral fellow. She is the Palestinian coordinator for the Trilateral Project 'Heart of flesh not Stone'. Zeina is author of *Sexual Harassment*, one of the few books in Arabic dealing with this taboo topic in Arab society. She is co-author of *Holocaust: Human Agony: Is there a Way out of Violence* (2012), which is a case study dealing with a personal transformation from extremism to moderation. She taught at the University of al-Quds University in Jerusalem, al-Istiqlal University in Jericho, and Friedrich Schiller University in Jena.

**Matthias Bauer** is Professor for film- and media-sciences at Europa-University Flensburg. He is the coordinator of the university course 'Kultur-Sprache-Medien' at EUF. He completed his studies in German, journalism, and history at Johannes Gutenberg-University Mainz. He obtained his doctorate degree in 1992, and his habilitation in 2002 with a thesis titled *Schwerkraft und Leichtsinn creative Zeichenhandlungen im intermediären Feld von Wissenschaft und Literatur*.

Amjad Abu El-Ezz is Assistant Professor at the Faculty of Economics and Administrative Sciences of An-Najah National University, Nablus. He worked at the embassy of the United Arab Emirates in London focusing especially on UK and EU foreign policies towards the MENA region and the Gulf. He is currently a visiting lecturer at Richmond University. Amjad is a trained journalist, he has spent 15 years of his career working in the Gulf and the Middle East, and five years as a Business Reporter for Emirates Business 24/7 and Al Khaleej Newspapers in Dubai. He holds a PhD from Durham University in Government and International Affairs.

**Gerd Hankel** is a Fellow of the *Hamburger Institut für Sozialforschung*. He is an expert of giurisprudence and language science. From 1998-2015 he was a Research Fellow at the Hamburg Foundation for the Advancement of Research and Culture (*Hamburger Stiftung zur Förderung von* 

Wissenschaft und Kultur). He is chairman of the non-profit organisation *Initiative Kongo e.V.*, and since 2002 he is researching the genocide in Rwanda.

Wietske de Jong-Kunru is a Junior Professor OF Protestant Theology at Europa-University Flensburg since 2016. Her research focuses on Theology of Religions and Interreligious Learning and she studied Protestant Theology in Kampen, Netherlands, and in Berlin, Germany, as an Erasmus-Student. Wietske completed her PhD thesis on post-colonial Feminist Theology and graduated at the *Protestant Theologische Universitaet Amsterdam*, Netherlands. From 2014 to 2015 she was research assistant at the chair for Religion and Mission Studies at Johannes Gutenberg University in Mainz.

Philip McCosker is the Director of the Von Hügel Institute for critical catholic inquiry (VHI), Fellow and Vice-Master Elect of St Edmund's College, and Affiliated Lecturer at the Faculty of Divinity, University of Cambridge. Philip took a first in Theology at Oxford University. After working as a lay-chaplain at the University of Rouen in France he was awarded a MTS in Systematic Theology from Harvard Divinity School. He went on to do his PhD thesis on models of paradoxicality in mystical christologies at the Faculty of Divinity in Cambridge under Denys Turner, completing much of the research while a Visiting Assistant in Research at the Department of Religious Studies at Yale University. Until 2012 he was Deputy Master of St Benet's Hall, Oxford. He is the Editor of the international reviews journal Reviews in Religion and Theology (Wiley-Blackwell). He edited What is it that the Scripture Says? Essays in Biblical Interpretation, Translation, and Reception in Honour of Henry Wansbrough OSB (T&T Clark, 2006); co-edited (with Denys Turner) The Cambridge Companion to the Summa Theologiae (Cambridge University Press, 2016), and he is currently completing Christ the Paradox: Expanding Ressourcement Theology (Cambridge University Press, forthcoming).

Thies Münchow is a Postdoctoral Research Associate at Europa-Universität Flensburg since September 2017, where he studied protestant theology and music from 2008 to 2012. From 2013 to 2014 he worked as a scientific assistant at the *Institut für Evangelische Theologie* at the Christian-Albrechts-Universität Kiel (CAU). Thies wrote his doctoral thesis on the subject of theological hermeneutics. He has published articles on philosophy of religion and contemporary phenomena of popular culture and writes for *Settimana News*. His current research interests are contemporary and historical theology, philosophy (of religion), hermeneutics, literature, and modern media.

Maria Palme is a research assistant at the Jena Center for Reconciliation Studies (JCRS), Faculty of Systematic Theology and Ethics, Jena University. Since 2013 she is a PhD Student at Europa-University Flensburg, with a thesis on 'Moral Principles when dealing with the Past of Authoritarian Regimes - A Comparative Analysis of German Parliament's Enquete Commission (1992-1994) and the Truth and Reconciliation Commission of Korea 'TRCK' (2005-2010)'. From 2013-2014 she was project coordinator of the International Summer School Series 'Societies in

Transition. Asia and Australia between Conflict and Reconciliation', and 'Former Soviet Union between Conflict and Reconciliation', in cooperation with Herder Institute for Historical Research on East Central Europe, Marburg University. From 2013 to 2015 she was co-editor of the book series 'Research in Peace and Reconciliation'. Maria's research areas are reconciliation policy, conflict transformation, transitional justice, restorative justice, and political philosophy.

**Iulia Patrut** is Professor for German Literary Studies at Europa-University Flensburg since 2015. She studied Anglistics and German Studies at University Bukarest, and Cultural Studies at University Lüneburg. She was a research assistant at University Trier and Professor of *Neuere Deutsche Literaturwissenschaft/ Literaturdidaktik* at University Paderborn. Her main research interests are German literature from 18<sup>th</sup> to 21<sup>st</sup> Century, intercultural German Studies and Postcolonial Studies, and Theory of Literature and Cultural Studies.

Elizabeth Phillips works at Westcott House, an Anglican theological college affiliated with the University of Cambridge, where she has taught since 2009. Her areas of expertise are Christian Theological Ethics and Political Theology. She obtained her doctorate in Divinity from the University of Cambridge in 2008 with her thesis 'Apocalyptic Theopolitics: Dispensationalism, Israel Palestine and Ecclesial Enactments of Eschatology. A theological ethnography of an American Christian Zionist congregation'. Elizabeth serves on the steering committee of the Society for the Study of Christian Ethics and as co-chair of the Scriptural/Contextual Ethics Consultation of the American Academy of Religion. Publications include *Political Theology: A Guide for the Perplexed* (Continuum, 2012), and (co-edited with Craig Hovey) *Cambridge Companion to Christian Political Theology*. Her research and teaching interests include the relationship between eschatology, ecclesiology and politics, and the ethics of war, peace and peacemaking.

**Stephen Plant** is Dean and Runcie Fellow at Trinity Hall, and Lecturer of Christian theology and ethics at the Faculty of Divinity, University of Cambridge. He has written and edited several books including *Bonhoeffer* (Continuum, 2004), *The SPCK Introduction to Simone Weil* (SPCK, 2007), *Letters to London* (SPCK, 2013), *Taking Stock of Bonhoeffer* (Ashgate, 2014). Between 2007 and 2013 he edited the journal *Theology* (SPCK/SAGE). His current research interests includes theology and international development, on which he is writing a book for Bloomsbury Press, and the theology and life of Karl Barth.

Maria Power is a graduate of Royal Holloway, University of London. She is a lecturer in religion and peacebuilding at the University of Liverpool where her work focuses on the role that religions can play in ameliorating violence and ethnic conflict. Her latest monograph *Seeking the Peaceable Kingdom: Cardinal Cahal Daly and the Pursuit of Justice in Northern Ireland* will be published in 2019. She is currently working on a study of the Catholic Church and Nonviolence which is under review by Bloomsbury Press. Maria has expertise in intra and inter-faith dialogue, the role of ethics in the work and business environment, and peacebuilding practices. She has

published and lectured widely on these topics both nationally and internationally. She has most recently published on peacebuilding in the *Journal of Social Encounters* and the *Journal of Contemporary Religion*. In 2017, along with Prof Chris Baker, Goldsmiths, University of London, she founded Power and Baker Consultants Ltd to help organisations improve their practices around diversity and inclusion.

Ashraf Suliman is the South African Ambassador to Palestine. He is a graduate of the International Relations and Diplomacy at Clingendael in The Hague. While at the South African Foreign Service Institute he received the Merit Award. Mr Suliman also attended the Diplomatic Programme for Senior South African Diplomats with the Indian Foreign Service New Delhi; he has held posts as the Counsellor for Political Affairs at the South African Embassy in Riyadh, Saudi Arabia, and he was the former Director of the Department of Foreign Affairs General, North Africa. He has played a central role in the co-ordination of Binational Commissions with North African countries. He also assisted and co-ordinated visits of South African Ministers abroad as well as foreign Ministers to South Africa. In September 2002 he accompanied the Minister of Foreign Affairs to Libya on the Lockerbie Issue. He is a member of the Interdepartmental Working Group on the World Cup Bid 2010.

Colin H. Williams was Research Professor in Sociolinguistics, now an Honorary Professor, in the School of Welsh, Cardiff University. He is a Visiting Fellow of St Edmund's College, and a Senior Research Associate at the Von Hügel Institute for critical catholic inquiry (VHI), University of Cambridge. His main scholarly interests are sociolinguistics and language policy in multicultural societies, ethnic and minority relations, and political geography. He was previously Fulbright scholar in residence and a visiting professor of the department of geography at Pennsylvania State University (1982-83), SSRC/SHFR exchange scholar (1982) and Swedish institute scholar (1988) at the Centre for the Study of International Conflicts, Department of History, University of Lund, and Adjunct Professor of Geography, University of Western Ontario (1994-present). In 2002 he was a Visiting Fellow of Mansfield College and Jesus College, Oxford University and a Visiting Fellow of Mansfield College again in 2010. In 2009 he was a Visiting Professor at the Department of Political Science, the University of Ottawa in connection with the SSHRC sponsored ARUC project on francophone rights in Canada. He has advised government agencies in Europe and North America on minority issues and currently advises the Welsh Government on its Official Language Strategies.

Heidemarie Winkel completed her studies in sociology and economics at the University of Trier, Germany, and received her *Diplom* in Sociology in 1993 and her PhD in 2001 at the University of Trier; in 2010, she completed her *Habilitation* at the University of Potsdam. She was research fellow in sociological theory and gender sociology at the University of Trier (1993-1994), the Technical University of Berlin (1995-2001) and the University of Mainz (2001-2002); and assistant professor at the University of Erfurt (2002-2005 & 2007-2009) and the University of Potsdam (2009-2011). Since 2011, she is an associated lecturer at the University of Potsdam. From 2005 to 2007 she completed a research project in the Middle East (funded by the German Research Foundation). She is a board member in two research sections of the German Sociological

Association (Women's and Gender Studies and Sociology of Religion); she is also the chair of the Research Network Sociology of Religion in the European Sociological Association (ESA) and member of the advisory board of *GENDER: Zeitschrift für Geschlecht, Kultur und Gesellschaft*. From summer 2013 until summer 2014, she was Professor of macro-sociology at the Technical University of Dresden. Since July 2015 Heidemarie Winkel is professor at the University of Bielefeld.

Ralf Karolus Wüstenberg is Professor for Systematic and Historic Theology at Europa-University Flensburg and a Senior Research Associate at the Von Hügel Institute for critical catholic inquiry (VHI), Cambridge. His research interests cover the fields of international Bonhoeffer research with focus on secularism and 'religionless Christianity', political ethics research on reconciliation and transitional justice in South Africa and German; interreligious research on Muslim-Christian Relations with a particular focus on doctrinal questions of grace, faith and salvation. His key publications include: *Islam as Dedication. A journey into the interior of another religion* (Minneapolis: Fortress Press, forthcoming 2018); *Verständigung und Versöhnung. Beiträge von Kirche, Religion und Politik 70 Jahre nach Kriegsende* (Leipzig, 2017); *A spoke in the Wheel.
