David Elliot is Assistant Professor of Moral Theology and Ethics, School of Theology and Religious Studies, Catholic University of America, and and Research Associate at the Von Hügel Institute for Critical Catholic Inquiry, Cambridge. David came to the Catholic University of America in 2017 after a 3-year postdoctoral fellowship as Research Associate in Theological Ethics at Cambridge University,. His research focuses on virtue ethics and the thought of St. Thomas Aquinas; including work on the theological virtue of hope, Scripture and ethics, and the art of dying. He received his Ph.D. in moral theology at the University of Notre Dame in 2014. He has worked on ethical and social issues with the Catholic Bishops Conference of England and Wales, as well as members of the British House of Lords, and he is an ethics analyst for the BBC. His first book is *Hope and Christian Ethics*, Cambridge University Press (2017). Recently his work on hope was awarded the \$4000 Essay and Book Prize from the Character Project of the Templeton Foundation for contribution to the study of character.

Elizabeth Fistein is Specialty Director in Ethics & Law, University of Cambridge School of Clinical Medicine, Medical Member of the First Tier Tribunal (Mental Health), and Member of the University of Cambridge Psychology Research Ethics Committees. She trained as a Psychiatrist in Manchester and Cambridge, and has worked as a Consultant Psychiatrist in both General Adult Psychiatry and Rehabilitation Psychiatry. Her research focuses on legal issues connected to consent to treatment and mental capacity, empirical ethics in psychiatry, and medical education (particularly ethics and professionalism education). She is part of the NHS Future Care Study on decision-making concerning eating and drinking for people with progressive neurological disease with and without decision-making capacity. Alberto García is Director of the UNESCO Chair in Bioethics and Human Rights, and Professor of Philosophy of Law and International Law School of Bioethics, Athenaeum Pontificium Regina Apostolorum, Rome. He has been awarded his doctorate in Law by the Complutense University in Madrid, where he is currently a researcher of the Human Rights Institute. For 5 years he has been member of the Steering Committee of Bioethics in the Council of Europe and in 2005 he has been honoured with the National Prize of the Spanish Royal Academy of Doctors in the field of legal and social sciences. He has extensive experience in several fields of ethics, such as bioethics, environmental ethics, science ethics, technology ethics, and ethics education. He has coordinated and published several books regarding different aspects of bioethics, including *The Destiny of Frozen Embryos*, Fundación Universitaria Española (FUE), Madrid, (2003), *Biotechnology and Ethics: Stem* 

*Cells and Human Cloning*, APRA, Rome (2008), and *Human Cloning: Ethical and Legal Aspects*, APRA, Rome (2008).

David Albert Jones is Director of the Anscombe Bioethics Centre, Oxford, Research Fellow in Bioethics at Blackfriars Hall, Oxford, and Research Fellow in the centre for Bioethics and emerging Technologies, St Mary's University, Twickenham. He is Vice-Chair of the Ministry of Defence Research Ethics Committee, and serves on the steering group of the 'End of Life Care Audit - Dying in Hospital'. He is a member of the Health and Social Care Advisory Group and the Department of Christian Responsibility and Citizenship of the Catholic Bishops' Conference of England and Wales, and of the Commission of the Bishops' Conferences of the EU (COMECE) Working Group on Ethics in Research and Medicine. His most famous books include *The Soul of the Embryo: An enquiry into the status of the human embryo in the Christian tradition* (Continuum, 2004), and *Approaching the End: a theological exploration of death and dying* (Oxford University Press, 2007). In 2009 he was a member of a working party of the General Medical Council which helped draft its 2010 guidance on *Treatment and Care Towards the End of Life* and was also on the National Reference Group of the Liverpool Care Pathway for the Dying Patient. He has contributed to a number of documents of the Catholic Bishops' Conference of England and Wales, including *A Practical Guide to the Spiritual Care of the Dying Person* (CTS, 2010), and *The Mental Capacity Act: A Practical Guide* (CTS, 2010).

William Junker is Assistant Professor of Catholic Studies at St Thomas University, MN, and Co-Director of the Terrence J. Murphy Institute for Catholic Thought, Law and Public Policy. He obtained his MA in Philosophy from Notre Dame University, and a PhD from the John U. Nef Committee on Social Thought and the Department of English, University of Chicago (2011).
